1. Complete the attached form (you may need your broker's assistance) and deliver it to your broker or financial advisor with regard to your wish to make a gift of securities to The Arts Club of Vancouver Theatre Society.
2. Your broker should contact and deliver the form to our agent, BMO Nesbitt Burns. Your broker should also forward the form to The Arts Club of Vancouver Theatre Society.

5. It is the Society's policy that securities, once received by the Society or its broker, will be sold and added to the Society's account in accordance with the Society's investment policies.
