Arts Club Theatre Company's 2025-26 Miriam Bennet Artist-in-Residence Program

The Arts Club Theatre Company is thrilled to announce a call for submissions to the Miriam Bennett Artist-in-Residence program. The program runs from October 2025 to July 2026. The deadline for submissions is October 1, 2025.

The Miriam Bennett Artist-in-Residence program is an initiative that provides mentorship, office space, and financial support to one artist for a theatre programming season. Its aim is to help an artist develop their practice and deepen their relationship with the community. The artist is free to pursue their craft in whatever way they intend without the burden of delivering a product. Our goal is to help clear their path a little so they may focus on their craft, which could be playwrighting, design, dramaturgy, performance, or any theatre discipline.

The Miriam Bennett Artist-in-Residence is provided with an office at our Granville Island Stage, two complimentary tickets to the opening night of all Arts Club productions over the course of the year, and a stipend of \$5000.

Expectations for the Artist during the residency include:

- Attend monthly check-in meetings with an Arts Club representative.
- Participate in special events throughout the year (fundraising initiatives, donor appreciation events, etc).

The Artist will be featured on the Arts Club's website and included in the company's promotional material.

HOW TO APPLY

Please include in the application:

- Brief biography and CV
- A statement outlining your artistic career goals and how you want to use the residency (max 1 page)

One Artist will be selected. Shortlisted candidates may be contacted for a follow up interview. Please note that, upon completion of the residency, a final report will be required. Decisions will be made in late September 2025 with the residency beginning in October.
